### 5. **PUBLIC COMMENTS**

Chair Angier opened the floor for public comments, in which the following speaker(s) came forward.

Dr. Marc Bivins, Medical Director, Positive Healthcare Partners, AIDS Healthcare Foundation to discuss the ongoing managed care negotiations between the District and Positive Healthcare Partners (PHP), as he opined that the District should further tax its constituents so that the cost to the AIDS community could be decreased.

Mr. Alex Fernandez, SVP, Chief Financial Officer, shared that for many years, the District had been a good community partner to Positive Healthcare Partners, providing high-quality healthcare and patient experience to those members who are living with HIV/AIDS. Mr. Fernandez further noted that it would be PHP's choice to terminate Broward Health as a provider, as the District was proud to have served more than 10,000 HIV-positive and AIDS patients through testing and care. In closing, the HIV/AIDS community was addressed and advised that the District would continue to provide care, despite the threats and actions of Positive Healthcare Partners.

In response to the PHP's public complaints, former Commissioner Joseph Cobo, came forward in defense of the District.

In response to the PHP's public complaints, the Board of Commissioners recommended to Dr. Bivins that the AIDS Healthcare Foundation abandon inflammatory rhetoric and contact Mr. Fernandez to resume negotiations in a professional manner.
